

**Rural Housing Task Force Meeting** 

In March, I convened the first meeting of a Glades Rural Housing Task Force to identify obstacles to rural and farmworker housing development in the Glades. My goal is to develop an action plan to implement solutions. Meeting via Zoom, the participants included Palm Beach County staff, Glades mayors and city managers, representatives from the United States Development of Agriculture Rural Development, and representatives from the agriculture, affordable housing, and lending industries. This was a fruitful discussion that led to several action items being worked on in advance of the second meeting.

# **Field of Hope**

In recognition of April as Sexual Assault Awareness Month, Palm Beach County Victim Services held its fifth annual Field of Hope event. Survivors, supporters and guests were invited to drive through the exhibits to see displays on various services for victims in Palm Beach County and read about sexual violence statistics. Participants could also stop and plant their flags with personal messages in the Field of Hope. Advocates, therapists, and Victim Services staff were available to provide encouragement and support.

I have worked for years on behalf of survivors, so it was an important moment for me to place my own message in the Field of Hope in support of all those who have suffered sexual assault.

A special shoutout to Rep. Randy Fine, who led efforts to pass legislation aimed at creating Sexual Assault Response Teams (SART) in every Florida county. We are fortunate to have one in PBC, and I am excited to see other counties will now have this wonderful resource.
