Opioid Epidemic Update

Palm Beach County continues to take strong action to combat the opioid epidemic.

On March 13, the County selected a legal team--Ferrero Law Firm, P.A., Napoli Skolnik, PLLC, and Stull, Stull & Brody--to pursue litigation on behalf of the County for costs, damages, and other relief associated with the opioid epidemic. It is vital that we hold accountable those responsible for the numerous

have seen in our County.

Furthermore, County staff continues to work with the Southeast Florida Behavioral Health Network on establishing a location for an addiction receiving facility. In the meantime, the County recently approved a contract with SEFBHN to expand treatment options. This will immediately expand the substance abuse treatment bed capacity in the County for residents experiencing or at risk of experiencing a substance abuse disorder. Through this contract, SEFBHN will identify and subcontract with agencies for the provision of additional treatment beds, including scholarships from private substance abuse treatment and detox facilities, and coordinate care for those needing housing and employment support.

Finally, I had the honor of participating in an opioids workshop at the National

Association of Counties Conference in Washington, D.C., in early March. I presented Florida's horrific overdose statistics, as well as Palm Beach County and Florida's responses to the epidemic, including an overview of which local governments in the state are pursuing litigation against those who contributed to this epidemic.

To end this crisis, a multi-faceted, intergovernmental effort is necessary, and I will continue to fight as hard as I can to build upon the progress we have made so far in bringing all levels of government together to do so.



School Safety Roundtable

The tragedy at Marjory Stoneman Douglas High School brought forth a groundswell of student activism that led to significant legislative changes made by the Legislature this

On February 28, I hosted a student roundtable at the Palm Beach County Main Library on school safety and support services. The purpose was to provide our County's students a venue to share with their elected officials what potential reform programs should look like at the state and federal level, as well as to create proposals for draft legislation.

We had a wonderful turnout with numerous passionate students who made their voices heard. Congresswoman Lois Frankel's office, the West Palm Beach Police Department, Palm Beach County Youth Services, and Forest Hill High School Principal Dr. Mary Stratos participated. I especially want to thank my fellow elected officials who also came to join the discussion with these amazing young men and women: West Palm Beach Commissioner Cory Neering, Westlake Councilwoman Katrina Long-Robinson, and School Board Member Erica Whitfield.

We should all be inspired by how thoughtful and compassionate these students are!



5th Annual Mayor's Ball

Mayor McKinlay hosted the 5th Annual Mayor's Ball to benefit the Homeless Coalition of Palm Beach County! Each year, the proceeds of this event help families and individuals find permanent housing, and this year there was record attendance with over 700 people! Senator Nelson Announcement on Dike Funding

In early February, Senator Nelson held a press conference in West Palm Beach announcing his efforts to secure the necessary funding in the bipartisan budget bill to complete the construction of the Hoover Dike. The bill includes \$10.4 billion for Army Corps of Engineers projects, and Sen. Nelson announced that he expects \$776 million of that to go towards expediting and completing the Dike by 2022, instead of 2025. Glades officials joined Senator Nelson during this event and discussed the safety necessity of finishing construction as soon as possible. Thanks also goes to Sen. Rubio for working with Sen. Nelson to get this done!



Legislative Session Appropriations

Largely due to redirecting funds to school safety, legislators did not approve many local appropriation requests this session. However, there were still significant appropriations approved that are important to District 6:

Pahokee Marina improvements: \$990,000

- Glades Communities Street Resurfacing and Reconstruction: \$1 million
- Royal Palm Beach Canal System Rehabilitation Project: \$150,000
- Small County Outreach Program: \$15 million (a \$6 million increase from last year's appropriation)
- Everglades Restoration Agricultural Community Training Program: \$1.5 million
- RESTORE Reentry Program: \$250,000
- Opioid epidemic: \$53.5 million

NACo Legislative Conference


