One of my resolutions for the new year was to update the design of our monthly Tax Talk newsletter, so check that one off my resolution list as complete! I hope you like the new design.

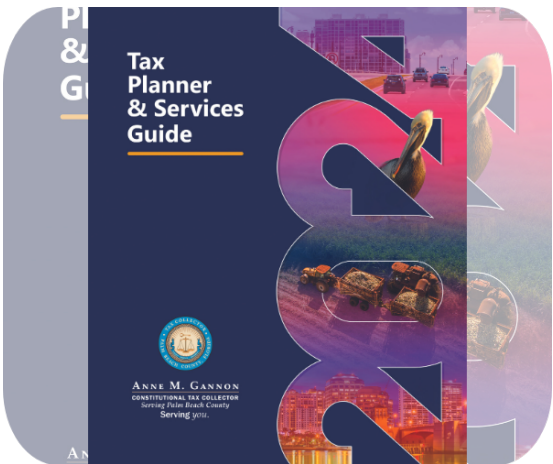
