There is no one best giving experience for us, as we are blessed with the position we have of being able to help families buy their homes, extend the services the communities have available, and we get to make several families' holidays just a little bit brighter with turkeys at Thanksgiving or by surprising hardworking families who don't expect it with toys and funds at Christmas. I can say there is no feeling like seeing someone work hard and purchase their first home, which is a foundation towards their future.

### What do you want your gifts to accomplish?

We just hope the tree donation brings Christmas cheer to the people you serve.







### WEST PALM BEACH (FL) CHAPTER OF LINKS, INC.

### Why did you first provide gifts to the seniors?

The Links, Incorporated has a primary mission of friends joining together in service to the community. We are so happy to be able to provide gift certificates to the seniors at the Senior Center through the Elves for Elders Program! We received a request for a donation and our members did not hesitate at all in responding to this request. We have been discussing ways to increase our service in the Western community, so the request was very timely. We have a project planned for the Spring for a group of daycare centers in the Western community, and now we have an opportunity to spread some holiday love to our seniors.

### What inspires you to give to charity/organizations?

We believe that to whom much is given, much is required. So, all of our members truly have a spirit of service. In order to make our communities healthier and vibrant, we must all do our part to give love and charity to our children, our elders, and our less fortunate.

### What interests you most about our organization? Why?

It is wonderful that the three senior centers provide services to seniors in our community and give them an opportunity to participate in programs and activities which enhance their quality of life. Studies have shown that people who have personal relationships with others live longer, healthier lives.

### What is the largest impact you've had in this community?

The West Palm Beach (FL) Chapter of The Links, Incorporated is best known for its annual scholarship fundraiser for students desiring to study the arts. However, we do so much more in this community. We are heavily engaged in promoting art appreciation by hosting events that showcase national and local

artists of color. We donate funds to local charities and nonprofits, such as Faith's Place, the Sickle Cell Foundation, Sojourner's With Healing Hearts, the Leukemia and Lymphoma Society, and the Urban League. We have volunteered and mentored foster care children at KidSanctuary Compass over the last four years and have supported the Leukemia and Lymphoma Society's Light the Night Walk for the last six years. We have registered African-Americans for the National Bone Marrow Registry, held a luncheon to celebrate International Women's Day, and recently hosted a reception and photo exhibit with the Spady Museum and Susan G. Komen entitled "Shades of Pink" to encourage African-American women to know and understand their risk for breast cancer. We work through our 5 Facets (The Arts, International Trends and Services, National Trends and Services. Services to Youth, and Health and Human Services).

### What's been your best giving experience?

My best giving experience has involved my work through The Links with Be the Match and the Leukemia and Lymphoma Society. I turned personal challenges to action: after losing my mother (age 54), sister (age 37), and aunt (age 41) to blood cancers, I started raising monies for cancer research and speaking at African-American churches, at UCF, and local community events such as health fairs about the importance of registering as bone marrow donors. We conducted registration drives in which the number of African-Americans registering for the National Bone Marrow Registry exceeded the goals established by Be the Match<sup>®</sup>. I have worked with The Links, Incorporated for the last six years to participate in the Leukemia & Lymphoma Society's Light the Night Walk to raise money to find a cure for blood cancers. In

particular, I emphasize public awareness of multiple myeloma, a blood cancer that primarily affects African-Americans.

#### How do you and your family or your organization make your philanthropic decisions?

The West Palm Beach (FL) Chapter of The Links, Incorporated makes philanthropic decisions by presenting opportunities for engagement to our chapter members and then voting on whether to donate money from our budgeted funds, by holding fundraising activities, or simply 'passing the hat.' We select charities and non-profits based upon issues that are important to our members and to the community we serve.

#### What would an organization need to show you, after you've made your gift, to convince you that you had made a wise investment?

An organization would need to show us the type of work that it does and how our donation/gift was used. We want to know that the organizations we support truly help people in need.

### How long do you usually stick with an organization or issue?

There is no set time. Again, we do a needs assessment, determine our priorities based upon the needs of the community and our chapter's capacity for philanthropy, and make decisions based upon issues that are important to our members and to the community we serve.

#### What shapes your giving?

Time, budget, chapter priorities, and need.

### What do you want your gifts to accomplish?

We want to know that the organizations we support truly help people in need.

### **DAVID GOODLETT**

### Why did you first provide gifts to the seniors?

In the early years of the West County Senior Center, my parents, Charles and Imogene Goodlett, frequently met friends there and participated in activities and lunch. Years later, a lady that provided childcare to me, Ms. Pearl Bell, of South Bay, came to the center. It was a place I could count on finding her. This opportunity reacquainted me with the folks and staff. My family and I brought Christmas dinner and gifts to Ms. Bell. She was alone and not in the best of health. In her nineties, she passed away, and my family was looking for another way to help others during the holidays. So, because of my parents and Ms. Pearl, the center was a good fit.



David Goodlett, Senior Vice President of Government and Grower Relations at Sugar Cane Growers Cooperative of Florida

#### What inspires you to give to charity/organizations?

First, my wife Michelle and I are blessed with three awesome children, Alison (32), Charlie (24), and Andrew (21). I thought it important for them to understand that everyone isn't as fortunate as they are. That's why they needed to know Ms. Pearl, who couldn't read or write and struggled for everything she had. Her connection with them left a lasting impression. So, first, being charitable was a "teaching opportunity"-a legacy I hope to leave with them. Secondly, I feel very fortunate to have been blessed in so many ways, far beyond my expectations. With those blessings come responsibility. In that regard, I believe that it's important for me to "leave this world a better place than we found it," and adhere to the Bible verse that says, "To Whom Much Has Been Given, Much is Expected."

### What interests you most about our organization? Why?

My original interest stems from the previously mentioned personal connection. However, I knew that the cause was worthy, and 100% of my investment would be used for the purpose for which it was intended.

### What is the largest impact you've had in this community?

Impacts are hard to see and measure. But without question, the most personally satisfying opportunity of my professional life was to serve on the Palm Beach Healthcare District and work with many folks to see the construction of Lakeside Medical Center.

#### What's been your best giving experience?

Giving is an opportunity. Opportunity comes in many forms, and doesn't always involve a financial contribution. As the Chair of the Palm Beach County Healthcare District, I was able to connect the Caridad Center and a young Guatemalan boy with a surgeon who repaired a birth defect and allowed him to walk for the first time. That was special—and I was merely at the right place at the right time.

# How do you and your family or your organization make your philanthropic decisions?

Sugar Cane Growers Cooperative has invested millions over their 50-plus year history. I believe the company, my family, and most

people give because of the relationship/linkage to the benefactor, the degree of "need," the return on the investment, and who is making the request.

#### What would an organization need to show you, after you've made your gift, to convince you that you had made a wise investment?

Personally, I have come to the conclusion that the benefactor is worthy prior to the contribution. But certainly the contributor would have to see that the investment resulted in the programmatic or capital improvement intended.

### How long do you usually stick with an organization or issue?

Seasonal opportunities like the gifts our employees make to the seniors are easily accomplished, much appreciated and the cost is manageable. Our folks look forward to this activity during the holidays. Many feel this has become a tradition and likely participate into the foreseeable future.

#### What do you want your gifts to accomplish?

In the case of the seniors, a smile along with the thought that someone cares.



### **CELECIA GAYNOR**

#### What inspires you to give to charity/ organizations?

I feel inspired to give to charity/organizations based on their mission to help/give back to others and by the commitment they show to the cause in which they represent.

### What interests you most about our organization? Why?

I am most interested in your organization because of the care that is given to the elderly. I have a genuine passion to care for others, especially the elderly. I strongly believe, that it is our job as the younger generation to care for those who have cared for us.

### What is the largest impact you've had in this community?

I would like to think that the largest impact I've had in this community is operating a business that provides genuinely caring, nurturing, and supportive services to our elderly community.

#### What's been your best giving experience?

### **SALESIA SMITH-GORDON**

#### What inspires you to give to charity/ organizations?

As a child, I was taught that service to others is the rent we pay for being on this earth. Because of my blessings, I have a naturally strong desire to help others. Resources are, of course, helpful, but so is the investment of personal time.



What is the largest impact you've had in this community?

Hmmm. First, caring about others. Other impacts are 2) professionally advocating for those who are unable to do so alone; 3) Assisting in the exposure, growth and education of others through academic scholarships to HBCUs particularly in the area of law and pharmacy; 4) Assistance of people through various resources and exposures to the arts. ### What's been your best giving experience?
