Provides direct services and acts as the community liaison for the Palm Beach County (PBC) Youth Reentry Program, as part of the Justice Services Division. Conducts outreach services to provide increased knowledge of, and connection to, public assistance programs, educational institutions, and other services related to the needs of juvenile justice-involved youth and families. Provides enrollment assistance for eligible activities and programs, such as completing and processing applications for rental/utility/basic needs assistance. Coordinates with community service providers; facilitates and/or provides transportation for clients to engage in services, and makes visits to youth and families at home, residential facilities, or other locations in the community. Develops professional connections and coordinates service pathways with agencies in the community to meet the variety of needs of youth and families. Increases public knowledge of mainstream public assistance programs. Work is performed alongside Youth Reentry Case Managers and under the general supervision of an administrative superior, and is reviewed through conferences, reports, and results obtained.

**QUALIFICATIONS:**

**Graduation from high school or an equivalent recognized certification; minimum of two (2) years of experience in social services/social work.**
