## FY24 - Tau Grants

Allegany Franciscan Ministries' FY24 Tau Grants will support unrestricted general operating and organizational capacity-building needs for organizations that provide services to the following marginalized groups: **BIPOC (Black, Indigenous, People of Color), LGBTQ+, and persons with disabilities.**

**To be considered for funding all of the following criteria must apply to the organization:**

- The organization did not receive Tau Grant funding in Fall 2021 – Spring 2022 or Fall 2022 – Spring 2023.

- At least 50% of the organization's population served falls within the marginalized groups identified.
- At least 25% of staff leadership individuals identify as BIPOC, LGBTQ+, or persons with a disability.
- The organization budget is \$2 million or less.

**Requests up to \$15,000 will be considered.**

## Funding Priorities

Priority will be given to organizations **focused** and **actively** working on one or more of the following issues:

### Access to Healthcare

Healthcare access is the ability to obtain healthcare services such as diagnosis, prevention or treatment that's affordable and convenient.

### Civic Engagement

Civic engagement refers to the ways in which citizens participate in the life of a community in order to help shape the community's future.

### Economic Mobility and Opportunity

Economic mobility can be defined as how an individual's financial well-being changes over a certain period of time. Generally, well-being is defined

in terms of income,  
earnings, or assets.
