

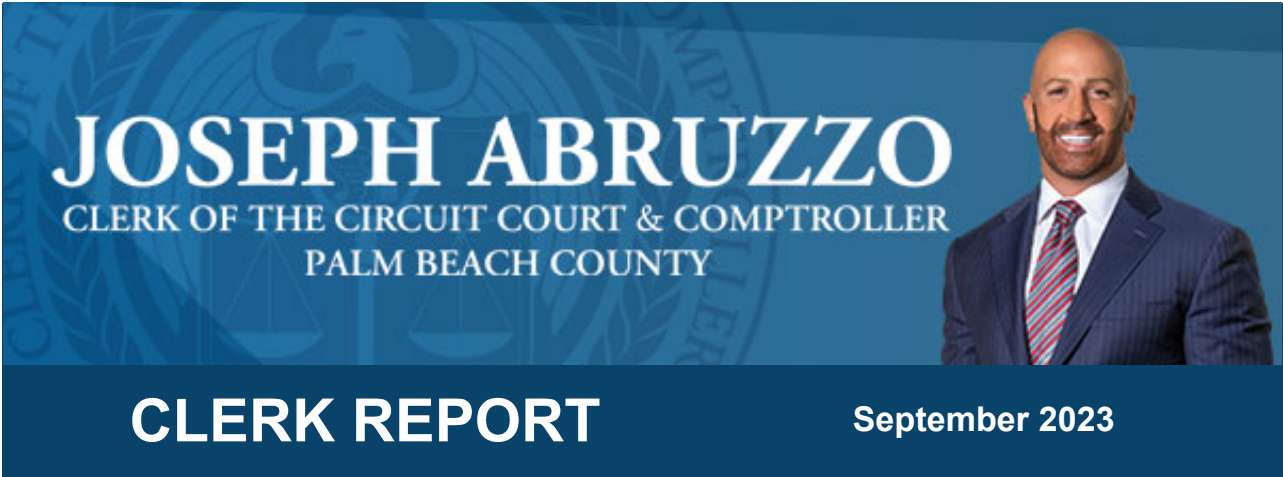

## Change to Uniform Case Number for Civil Cases

As of **September 1, 2023**, the format of the Uniform Case Number for all civil cases created on or after September 1 has changed.

The last four digits of the case number preceding the location indicator will be changing from XXXX to XXXA. Please use the new required format whenever you are typing the entire case number into any of our systems or including it on a pleading.

This change will not affect any cases created prior to September 1, 2023.
