## Elements of Effective Practice: Standard 4-Matching & Initiating 7/7/23 I 9am-12pm

Matching helps create appropriate mentoring relationships by using strategies most likely to increase the odds that the relationship will be safe and effective. Matching should consider individual characteristics about the mentor and mentee in order to foster an enduring relationship. Initiating is the step that formally establishes the mentoring relationship.

### **QPR- Suicide Prevention** 7/7/23 | 1-2:30pm 7/24/23 | 10-11:30am

QPR is a basic suicide prevention training that shares suicide statistics, myths and facts, risk factors and warning signs, and creates community suicide prevention gatekeepers able to identify suicide risk, talk with people at risk for suicide, and enlist help and resources.

Participants will learn how to recognize the warning signs of a suicide crisis and how to question, persuade, and refer someone to help. The training will model how to enhance, expand, and implement culturally sensitive, evidence-based (EBP) suicide prevention and early intervention strategies.

## High Five Discipline: Positive Parenting for Happy Healthy Well-Being Kids 7/14/23 I 10am-12pm

When confronting the challenge of disciplining their children, moms and dads often default to the ways their own parents disciplined them, sometimes with harmful results. In High Five Discipline, mom and practicing pediatrician Dr. Candice Jones shows parents a better way. Dr. Jones coaches parents to understand their child's developmental stages and their own motivations to create a family discipline plan that manages misbehavior and encourages good behavior. Her advice is packed with developmentally appropriate strategies to tame tantrums, stop sibling squabbles, and reward better behavior to create a calmer, more harmonious home. In learning and sharing these strategies, children will be less vulnerable to possible abuse and neglect situations.

Training focuses on ensuring that prospective mentors, mentees, and their parents or guardians have the basic knowledge, attitudes, and skills needed to build a safe and effective relationship. Training of mentors, particularly, has documented implications for the length of match relationship as well as both parties' perceptions of the quality of the relationship.
