# **PRIDE, PETITIONS, POSTCARDS & MORE**



Summer is upon us and June is Pride Month. We need to remember that democracy is for everyone and ensure the rights of all to participate in our government *and* feel safe and secure in their community. The Voter Services team works to make sure citizens in Palm Beach County are registered to vote, and I am happy to say they registered nearly 1,000 graduating seniors in Palm Beach County schools. The team works throughout the summer to register voters and make sure voters realize they have to renew their Vote By Mail application.

We have many projects going on throughout the

summer. A coalition entitled Floridians Protecting Freedom has launched a citizen-led ballot initiative campaign to give women the right to seek abortions up to viability. Florida voters want women to have the chance to ensure that their personal medical decisions are theirs and theirs alone to make. The League of Women Voters of Florida Board of Directors has voted to support this citizen initiative effort. We are collecting signed petitions to put this issue on the 2024 General Election ballot. You can join other members in this effort. More information is included below on what you can do. We also will have petitions at our meetings.



## LET'S GET ABORTION ACCESS ON THE BALLOT

League helps Floridians Protecting Freedom drive for Constitutional Amendment.

Most of us were crushed when Roe v. Wade was overturned by the Supreme Court recently. Many of us remember a time when abortion was not legal. Women died getting illegal ones.



The difficulty with laws restricting abortion is that many women have problems carrying a fetus, and the problems show up well after most new laws say abortions can't be performed. So women carry dying babies, which is harmful to their health, and they have to consult their lawyers rather than their doctors. Some women have to travel to states where abortion is

available, which many can't afford, or wait until they are close to death, when they might be allowed to get an abortion. A group of women recently sued, saying the new laws are a threat to their lives and health. In addition, the majority in the United States favors abortion in all or most cases.

#### LEAGUE JOINS CLEAN WATER PETITION DRIVE

The League of Women Voters of Florida has joined the campaign to support getting a constitutional amendment on the ballot in 2024 for civil action to enforce our right to clean and healthy waters in Florida.

The "Right to Clean and Healthy Waters" is a stopgap, declaring that "no more harm" will be allowed to our waters. The campaign's mission is to take this to Florida's voters; to educate them, to collect their petitions, and to ensure their voice is heard.

Why has the League agreed to help this effort?

- 1. Everyone needs and deserves clean water.
- 2. Our health, our economy and nature all depend upon clean water.
- 3. But thousands of Florida's waterways are polluted because polluters have rights and special interests have undue influence in Tallahassee.
- 4. The buck stops with the state.
- 5. With a "Right to Clean and Healthy Waters," citizens can hold the state accountable.
- 6. We can stop pollution at the source and protect our families, secure our livelihoods and help nature flourish.

# You can help decision-makers solve infrastructure needs.

Palm Beach County citizens are growing in their awareness of the significant new resources pouring into local housing, transportation and infrastructure projects. Federal, state and local money has been provided at unprecedented levels for these purposes. Much of the funding involves federal dollars "washed through" the state budget. The decisions that local officials are making now will have notable impacts on the places where we live and move.

League members have immediate opportunities to participate in these deliberations. We can observe, in



person but especially electronically, what is going on. Most area jurisdictions televise and record their official sessions. Go to the websites of your municipality, the county and the Legislature. You will find current and recent information about what is happening. Then you can call, visit, email and use the Internet to connect with the decision makers. Typically, our members have joined the League because they want to be informed and active in public policy. Now is an exceptional time to express one's position. It has never been easier to input your thoughts into the public square.



#### **PB TRANSPORTATION PLANNING AGENCY: A PRIMER**

Have you ever wondered how roads are constructed and how bike lanes are built in certain areas? The Palm Beach Transportation Planning Agency (TPA) is a federally mandated public agency that works with partners across Palm Beach County to plan, prioritize and fund the transportation system. The TPA

conducts planning studies, annual planning documents and a Long Range Transportation Plan to create a balanced transportation system to enrich the quality of life for the people who live, work and play in Palm Beach County.



The TPA consists of a 21-member Governing Board of locally elected officials, which prioritizes more than \$600 million of federal, state and local transportation dollars to implement projects that advance our regional vision for the nearly 1.5 million Palm Beach County residents. The Governing Board is supported by staff and three advisory committees.

#### LWVFL Sues State for Hampering Voter Engagement Efforts

**TALLAHASSEE** — The League of Women Voters of Florida, represented by the Campaign Legal Center, sued Florida Attorney General Ashley Moody and Secretary of State Cord Byrd on May 24 to block provisions of Florida's recently enacted omnibus election law that would restrict and penalize basic nonpartisan civic engagement efforts. The law, Senate Bill 7050, directly targets and drastically restricts the ability of nonpartisan civic engagement organizations, like the League of Women Voters of Florida, to engage with voters, violating their right to freedom of speech and association.

"Folks helping their neighbors access and exercise the fundamental freedom to vote is one of the pillars of our democracy," said Paul Smith, senior vice president at Campaign Legal Center. "Instead of celebrating civic engagement groups for their work to encourage participation in our democracy, Florida legislators restricted and penalized basic voter outreach efforts. This action will directly harm members of historically marginalized communities – including voters of color, low-income voters, voters with disabilities and young voters – who rely on these nonpartisan efforts to help make their voices heard."

#### Another stellar year for voter registration at PBC high schools.

Voter Services had its biggest year ever doing voter registration at the high schools in May. We got 962 voter registration forms filled out by Seniors doing their final checkout prior to graduation. When the Seniors are about to graduate, they have to collect their caps and gowns, pick up their yearbooks, and pay related graduation fees, among other things.

They also must register to vote. This is the final step in preparing the Seniors for adulthood. And it *is* literally the final step, since we are usually the last stop in the checkout process. When we were finished this year, there were almost 1,000 new registered voters in Florida.



Registering to vote is part of the education process of the students. When we ask, "Are you registered

to vote?," we often hear "Vote for what?" This year, we could say "in 2024 you'll be able to vote for President!" That seemed to thrill many.

U.S. Election Assistance Commission cites team for innovation, sustainability, replicability.

Congratulations to Wendy Sartory Link, Palm Beach County Supervisor of Elections, and the staff at the Elections Office.

The Clearinghouse Awards, also known as the "Clearie" Awards, are presented annually across the United States for best practices in election administration by the <u>U.S. Election Assistance</u> Commission. Established by the Help America Vote Act of 2002, the EAC is charged with serving as a clearinghouse for election administration information. To further this mission, the EAC launched the Clearies in 2016 to promote best practices in elections and celebrate the accomplishments of election officials.



Our very own Supervisor of Elections, Wendy Link, was the winner of the Outstanding Innovations in Elections for programs that use

creative tools to improve election administration, while advancing new and innovative concepts, for large districts. The Palm Beach County Supervisor of Elections office was first in the nation to offer early voting appointments during the 2022 Primary and General Elections. The program, No Wait Inside, launched successfully with 21,356 voters who participated.



#### YOU SAID IT

#### Large body of misinformation is fueling American gun violence

This 'Your Turn' opinion column was published in The Palm Beach Post on June 7.

Slogans like "Guns don't kill, people do" and "The only thing that stops a bad guy with a gun is a good guy with a gun" reflect the decades-long campaign by the gun lobby and its allies to convince Americans that owning guns makes them safer. This campaign, based on a large body of misinformation, has made America a far more dangerous place. <u>Our book *American*</u>

<u>Carnage</u> identifies and debunks close to 40 core myths that have led many Americans to mistakenly believe that carrying a gun and keeping one in the home will protect them rather than expose them to an elevated risk of harm.

Much of this misinformation stems from the radicalization of the gun lobby, beginning in the 1970s. Since then, the gun industry and gun rights organizations have made it their priority to convince Americans that an armed citizenry is the most effective way to shield ourselves from violence. This campaign has included stoking the public's fear of crime, funding dubious scholarship by gun-friendly researchers, and shutting down federal funding of research showing that guns in the home put occupants at an elevated risk.

#### FROM OUR NEW BLOG... Don't be fooled by anti-union propaganda

This Letter to the Editor by Palm Beach County League member Mary Mertz was published May 19 in the Sun-Sentinel.

In a recent opinion piece ("DeSantis offers a lesson in freedom"), state Rep. Spencer Roach, of North Fort Myers, would have you believe that crippling teacher unions teaches students about freedom.

On the contrary, Roach provides a perfect example of the level of deception and doublespeak by state leaders to fool Floridians into thinking they are protecting our freedoms when in fact they are increasing restrictions on freedom. Don't believe a word of their propaganda.

If kids in Florida are learning about freedom, it's because they're learning what it isn't. When books are banned, it's not freedom. When certain populations such as Blacks or LGBTQs or immigrants have their history rewritten or erased, that is not freedom. When parents are prevented from making health choices for LGBTQ or pregnant children, that is not freedom.



#### A MILESTONE GIFT: WOMEN'S SUFFRAGE GAME



Votes for Women, designed by Tory Brown and published by Fort Circle Games, recounts the story of how suffragists won the right to vote in 1920 through the 19th Amendment. The card-driven game detailing events from Seneca Falls, N.Y., to the ratification of the 19th Amendment features period artwork and historical documents.

The League of Women Voters was founded in Chicago in 1920, just six months before the 19th amendment was ratified and women won the vote. The League began as a "mighty political experiment" designed to help 20 million women fulfill their new responsibilities as voters.

"Women had to fight to win the right to vote, and particularly today, when democracy is under threat, we look for new ways of sharing our history and the

importance of voting with the next generation of voters," said Virginia Kase Solomón, CEO of the League of Women Voters of the US. "Votes for Women is an engaging way to share those lessons as we strive to protect every American's freedom to vote."

The 19th Amendment was a major milestone in American history and an incredible accomplishment for a social movement; however, it did not guarantee all women the right to vote.

The amendment notably enabled states to exclude Black women, especially in the South, and allowed the federal government to deny other women of color citizenship.


